

AFFIDAVIT – HOMEOWNER

To be completed upon initial enrollment (or at any time upon the request of the District) into the District by parent, guardian, or other person with whom the student currently lives and who is presenting the student for enrollment.

NOTE: Any person who knowingly enrolls or attempts to enroll in the schools of a school district on a tuition-free basis a student known by that person to be a non-resident of the school district and any person who knowingly or willfully presents to any school district any false information regarding the residency of a student for the purpose of enabling that student to attend any school in that district on a tuition-free basis shall be guilty of a Class C misdemeanor. Anyone who knowingly or willfully provides false information on this form shall be referred for criminal prosecution. In addition, if it is determined that a student has been attending a school within the District on a tuition-free basis, but is a non-resident, the person who enrolled the student will be charged tuition for each day of the student’s attendance at a rate of 110% of the previous school year’s per day per student tuition cost plus all of the District’s fees and costs associated with investigating and determining the student to be a non-resident of the school District.
